What We Do

We work primarily in two strategic channels of advocacy:



LEGAL

We are engaged in legal advocacy through the work of our in-house legal team comprised of more than 60 highly qualified lawyers, working alongside our network of more than 3,200 Allied Attorneys around the world.

COMMUNICATIONS

In addition to success in the courtroom, we recognize the critical importance of being directly engaged in the **courtroom of public opinion**. To that end, we have a dedicated team of communications professionals committed to measurably impacting key cultural debates.



Transformational Legal Training

FOR TODAY: We train practicing attorneys in constitutional law and biblical worldview at our **Alliance Defending Freedom Academy**, building a formidable force to secure and advance religious freedom. Since its launch, ADF Allied Attorneys have provided more than \$200 million in pro bono service in defense of religious freedom.

FOR TOMORROW: We train law students—and those considering entering legal and culture-shaping professions—through our **Blackstone Legal Fellowship** and **Areté Academy** leadership training programs, respectively. More than 2,500 students have been trained and deployed, directly and powerfully creating an impact on current and future seats of influence.

International Outreach

With headquarters in Vienna and additional offices located in other centers of legal and political influence, ADF International is at the forefront of defending religious freedom, the sanctity of life, and marriage and family around the world. Additionally, we have consultative status at the United Nations in New York City and the Organization of American States in Washington, DC, and have secured 17 victories at the European Court of Human Rights, one of the most influential courts in the world.



Who Founded ADF

In 1993, Christian leaders from across the country gathered to address the growing peril to religious freedom in America. These leaders, including Dr. Bill Bright, Dr. James Dobson, Dr. D. James Kennedy, Larry Burkett and more than 30 others, recognized that those who sought to defend this God-given, constitutionally protected principle in the courtroom were undermanned, undertrained, and underfunded. From that critical meeting, Alliance Defending Freedom was founded.
